#### Important changes to how you make payments to Inland Revenue

Do you pay Inland Revenue by cheque or make payments at Westpac? If so, you need to be aware of recent changes to our payment services. Westpac will continue to accept cash or eftpos payments over the counter after 1 October 2014 but they'll no longer accept any cheque payments, returns or other documents.


From 1 October 2014, cheque payments and returns must be received at Inland Revenue on or before the due date to avoid late payment penalties and interest.

Posted cheques must be received on time

Tip: Use your internet banking. Just go to your bank's website, log in and use their tax payment service. Your payment will show up on your bank statement straightaway. You can make your payments right up to and including the due date. To find out more visit the IRD Website.
